Location of the school*:

Bishop Ridley School is situated on Northumberland Avenue, which is a residential road running between Welling and Falconwood. Throughout the day this is a quiet road, as are the surrounding residential roads.

We are situated next to Harris Academy, a secondary school. We share a playing field and we have access to their grounds via a gate which is only unlocked when we use the nearby church. There is no entrance from Harris Academy for parents and children during usual school hours/days.

Pedestrian and school entrances*:

The entrance to our school is situated at the front of the building. This entrance is for vehicles and pedestrians – a coded barrier has recently been installed for staff vehicle access and a separate path for pedestrian use with a new, sturdy fence/barrier. This has improved the safety issue. Following this entrance round, you will arrive at the staff car park.

From the main entrance, vehicles can drive through a set of gates enabling them to be nearer the building - used by Gate Venture (school lunch delivery).

There are also parking spaces at the front of the building for visitors.



The nearest bus stop to the school is further down Northumberland Avenue, a 5 minute walk from the entrance. This is served by the B16 route, which runs between Bexleyheath, Welling and Eltham. There is also a stop for the B15 route at Falconwood Station (5 minutes walk), which comes from Eltham, via Avery Hill and Crown Woods Secondary School.

Trains* :

Falconwood railway station is a 5 minute walk away from the school entrance. This station is on the Bexleyheath line from Dartford to London Charing Cross, Victoria and Cannon Street stations, operated by Southeastern trains.

Roads* :

There are three main roads around our school: Welling Way, Bellegrove Road and East Rochester Way. They are linked to our school via a network of smaller roads. The A2 main route into central London is also only 5 minutes drive from the school.

Mr Hall, HT, informs parents via the newsletter when we are taking part in Walk to School Week and of any parking issues around our school. We did take part in the Walk Once a Week scheme, but found the recording side of this impractical and questioned the benefit of this to our school. Our Yr2/3 classes entered the Design a Badge competition using sport as a logo. Our JRSOs have visited the Transport Museum in London with other schools and also the JRSO workshop/celebration event in Bexley. They are hoping to attend this year's event in July.

Walking Initiatives:

We took part in the WoW scheme, encouraging the children to walk once a week and record this in class. Infant class responses were recorded by the teachers, who reported that the problem was children saying they walked to get a sticker and tears if they didn't. Older children were encouraged to complete the sheets themselves, which proved to be confusing...some were completing in advance for dates when we not at school! This was all rather time consuming and so we decided to opt out of this scheme.

We are planning to show maps indicating roads where children should be encouraged to walk from. We also took part in the Walk to School Week titled 'World Cup' in May 2010.

Cycling Initiatives:

13 of our Yr6 pupils took part in Level 1 cycle training in June 2011.

Smarter Driving Initiatives:

We are planning to display maps indicating addresses where pupils are encouraged to walk from and showing roads where cars can be parked away from the school entrance.

Public Transport Initiatives:

Our Year 2/3 classes used rail travel when visiting a local theatre related to literacy. 90 children plus staff travelled from Falconwood to Dartford in April 2011.

Road Safety Initiatives:

We have included road safety education within Citizenship lessons for KS1 and have used resources from the JRSO scheme. Our JRSOs have prepared and spoken in assemblies and also visited our nursery children, taking part in role playing related to road safety.

Partnership Initiatives:

We have support from the local PCSO scheme. One of the team has been visiting the school on a Friday morning, watching class assemblies and talking to parents afterwards. She also joins the children in the playground to enable them to chat to her about safety issues/concerns in the area.

Curriculum Links*:

Our Yr2/3 classes have worked on road safety as part of their Citizenship lessons, using some of the resources from our JRSOs. They have also researched the Olympic Games 2012 and this proved useful when they took part in the Design a Badge competition, using sport as a theme.


